The ECU or East Care Unit is empty after being nearly continuously occupied since October 21, 2020 with residents who have tested positive for Covid-19. The last resident returned to their room on Monday, January 25, 2021. It is hopeful with the booster vaccine being administered on Thursday, January 28, 2021 that we will very shortly be Covid-free going forward into the future. 216 vaccine shots are expected to be given on Thursday – most are the booster vaccine but some are the first vaccine dose.
