I was born at the McPherson Hospital to Clifford and Marie (Jantz) Becker on December 6, 1932. I had 5 sisters; Frances, Florence, Bertha, Carol, and Nina and 4 brothers; Franklin, Freddie, Jimmie and Lawrence. Frances and Jimmie have passed away. Growing up, I lived at different places in McPherson County. I started school at Lincoln School in McPherson. Next, I went to school in Moundridge. Then we moved and I went back to Lincoln School. The next move I attended school at Inman. We walked around Inman Lake going to school. We moved again and I attended Santa Fe School which was south of McPherson. We walked 1 ½ or 2 miles depending on which way we went. I carried my younger sister piggy back as we walked over the tops of snowdrifts in the winter. I married Lincoln Koehn on December 18, 1955. He was having a house built for us, but it was not quite finished so we lived with his parents on east Pack Street for a couple weeks. When it was finished, we moved to our house on Lincoln Street. We lived there together until Lincoln moved to Pine Village and then Moundridge Manor. He passed away in June of 2006, and I continued living there until I moved to the Manor on June 11, 2020, almost 65 years in all. We adopted Janell when she was about 2 weeks old, and Angela was born seven years later. Besides being a housewife and mother, I did house cleaning for others. I also worked as a housekeeper here at the Manor for 9 years until I retired. I enjoyed gardening and canning and I liked to bake goodies to give away. I enjoyed going to sewing at church to quilt. I have four grandchildren; twins Tyler and Trevor, Tonya, and Jordan (and Trevor’s wife Nicolee) I moved into the Manor right in the middle of the Covid pandemic. Now my pastimes are watching birds at my feeders, doing word puzzles, coloring (especially kitty cats), and reading. I am trying to read the Bible from beginning to end. I look forward to Angela stopping in almost every day. I enjoy phone calls from family, and listening to singing in the evenings

## ACTIVITY INFORMATION

You will receive 24 tickets each week to spend on Manor Store items beginning the week of March 29. Also, you will receive tickets for activities attended.

For activity requests you may come to the Activity Office in Cottonwood Pointe or call the Activity Office at (620) 345-6364, ext. 305.

We have resumed once a month shopping for resident requests from Wal-Mart on the first Monday of each month so plan accordingly. The next shopping day will be Monday, June 7, 2021.

Personal deliveries are NO longer being held for 24 hours – we will check the delivery box at approximately 9:00 a.m. and 3:00 p.m. each day.

The Manor received permission from the county health department to move into Phase 2 on March 23, 2021. Dining has resumed in the Courtyard Café and Sunshine Diner with social distancing. Group exercises and activities will be held while maintaining social distancing. Visitors may have in-room visits by appointment. The Manor is in regular communication with your primary representative and keeping them informed of all developments. McPherson County recommends the following beginning May 6, 2021: no gathering limits when all persons wear masks; 6-foot distancing when possible; if all persons in gathering have been fully vaccinated for at least two weeks, masks and distancing may not be necessary. Businesses may set their own guidelines at their discretion.
